

**PRINCE GEORGE FARMER MARKET
VENDOR'S AGREEMENT**

PURPOSE OF THE MARKET:

The Prince George Farmers Market is a key component of a vibrant, diverse and exciting Downtown. It is designed to serve and bring together all segments of our community. It is a positive force in bringing people Downtown to purchase fresh produce and local crafts. The Saturday Market is a showcase for the talents and the work of local artisans and local growers. It is a great place to meet !

MARKET MANAGER:

The Market Manager shall have management responsibility for the operations of the Market. Responsibilities will include, but not be limited to supervision of Market during operating hours, recruitment of new Vendors, communication with Vendors and responding to their needs and inquiries, implementing and enforcing all rules pertaining to the running of the Market in a fair and equitable manner, creating an open and friendly atmosphere at the Market and implementing regular, ongoing special activities at the Market. The Market Manager will have full authority to enforce all rules and regulations as necessary and may ask the Board to suspend a Vendor for a serious violation of the rules.

HOURS OF OPERATION:

The Prince George Farmer Market shall be open every Saturday of the year (except when December 25 or January 1 falls on a Saturday) from 8:30 AM to 2:00 PM.

VENDOR REQUIREMENTS AND REGULATIONS:

To ensure a larger variety of product, the Board will assign each Vendor **ONE SINGLE** designated area to display and sell his/her merchandise. The sizes of booth are 5 feet wide by 7.0 feet (5' x 7.0') deep, though there may be variations in this format in certain areas of the Market. Vendors will not operate beyond the area assigned to them, except as pre-approved by the Board at its discretion.

On signing this contract, each Vendor **MUST** complies with the following; failure to do so may be grounds for termination of the Vendor Agreement and registration.

- The Prince George Farmer Market Rules, Regulations and Bylaws.
- Municipal, Provincial and Federal Regulations regarding namely but not limited to parking regulation, business license, labelling, health and safety and any other regulation for all products offered for sale at the market.

FEES

Rates for areas shall be 25.00 \$ weekly for a single booth of 5X7
Rates will be adjusted if there is a variation in this format.
GST is payable on booth fees and will be add to the following rent. Fees will be review yearly.
A \$35.00 charge will be levied for NSF cheques.

Booth fees shall be payable as follows (check one):

LIABILITY AND INDEMNIFICATION

Vendor is solely responsible for damages resulting from the sale of unsafe or unsound goods. Vendor is solely responsible for damages or personal injury resulting from the use of any equipment including umbrellas and other weather protection devices. The vendor hereby agrees to indemnify, hold harmless, release, waive and forever discharge the Prince George Farmers' Market Association, its employees and its Boards for all bodily and personal injuries, including injuries resulting in death, and property damage, claims, actions, damages, liabilities and expenses, including reasonable attorney's fees and court costs, which may occur as a result of Vendor's participation in the Prince George Farmers' Market, whether or not sounding in tort of contract, and whether or not caused by a negligent act or omission of the Prince George Farmers' Market, its employees or its boards.

VENDORS DECLARATION

I, the undersigned, have read and am fully aware of Prince George Farmer's Market rules and regulation. I agree to abide by the terms described herein. I understand that the Board has the right to remove from the market vendors who do not comply with these rules and agreement.
